length will be 75m in front of the grandstand with a 4m gate on rails with locks. 90 degrees turn to the grandstand wall with a 3m clearvu fence that is divide in half to allow for a 2m gate in the middle of the 3m fence.

Install fence from the left-hand side of the grandstand parallel the right-hand side that has a 2m gate, but this left-hand side will not have a gate but the fence only up to the edge of the running track that will be 5m fence from the grandstand.
